The online technical bids were opened on 28^{th} October 2016. In response, following bids were received: -

After the preliminary scrutiny, the Technical bid opening Committee observed that the offline bid submitted by Institute for Human Development, Delhi has to be treated as non-responsive as it failed to submit the bid through e-procurement and therefore, not-qualified for technical evaluation.

Sh. Surajit Das, Consultant JNU and Dr. Ash. Narain Roy, Director, Institute of Social Sciences (both for the theme no.2) have been asked to submit the authorization from their respective organizations which they complied with.

The Committee recommended for technical evaluation of the above said bids totaling number 20 received for 12 themes of studies by Consultant Selection Committee (CSC).

Sh. K.K. Pandey, Professor, IIPA, Professor A.K. Singh, UGC Centre for Federal Studies, Jamia Hamdard, Sh. Prakash Chand, Controller of Accounts, Govt. of Delhi, Sh. K.N. Sharma, Jt. Secy. Finance Deptt, Govt. of Delhi expressed their inability/ failed to appear for technical evaluation.

The Consultant Selection Committee (CSC) comprising Sh. B.K. Sharma, Retd. Director (Dte. of Economics and Statistics, Govt. of Delhi) and presently Advisor to the Government, Sh. Hari Prasad, DCA (East DMC) and Dr. Babu Lal Pathak, Consultant, 5th DFC have technically evaluated the above bids.

While scrutiny it is observed that All India Institutes of Local Self Government, Delhi has submitted bids for ten themes, out of which in case of five themes i.e. theme no. 1,7,8,9 and 17 the key professionals i.e. Team Leader and Research Assistant are the same. The details given in tech 5 and 8 also indicate the same work schedule.

As per the terms and conditions of the tender given at point 5 of section 2, the consultant or the professionals hired for an assignment should not have any other conflicting assignment/job.

Para 5.2 of section 2 says "Conflicting Assignments/job: A Consultant (including its Personnel and Sub-Consultants) or any of its affiliates shall not be hired for any Assignment/job that, by its nature, may be in conflict with another Assignment/job of the Consultant to be executed for the same or for another Commission".

In this case i.e. in case of themes 1,7,8,9 and 17 the professionals assigned by the All India Institute Local Self Government, Delhi amounts to conflicting assignments/ jobs and, therefore, the tenderer contravenes the above said provisions and , therefore, to be treated as non-responsive.

As a result:

- 1. Theme no. 1,9,17 are left with no bids.
- 2. Theme no. 6,7,8 and 13 are left with single bids.
- 3. Theme no. 11, 12, 14 and 16 have two bidds each.
- 4. Theme no. 2, has three bids.
- 5. Theme no. 3, 4,5, 10 and 15 have not received any bid.
- 6. Ultimately Theme no. 1,3,4,5, 9, 10 ,15 and 17 have no bids for financial evaluation

Sufficient number of tenders were not received in spite of all measures as prescribed in the Rules were taken.

The Technical Committee concludes that the following fifteen tenders for 9 themes which are technically qualified can be considered for financial evaluation.
